## **THE EASY TO UNDERSTAND VERSION:**

### **Official Rules**

By entering this contest, you agree to play nicely and follow the rules.

#### **1. Sponsor:**

You don't have to buy anything to win.

And buying stuff won't help your chances of winning.

(But we still appreciate it.)

#### **2. Eligibility:**

You must live in the continental United States.

Anyone under the age of 21 wishing to enter must have a parent or guardian complete the registration.

Parent or guardian must be 21 or older.

#### **3. Competition Period:**

Contest starts at 12:00:01 am EDT on May 26, 2023.

Contest ends at 11:59:59 pm EDT on June 16, 2023.

#### **4. How to Enter:**

Go to <https://familymomentsfun.com>.

Follow the instructions to register your contact info and answer questions.

#### **5. Submission Guidelines and Restrictions**

Your entry must be in English.

Your video entry must be between 30-60 seconds.

Your entry must be posted on facebook with the tag @Family Moments.

Family Moments will approve your video and post it on the Family Moments facebook page. ([www.facebook.com/familymomentsfun](http://www.facebook.com/familymomentsfun))

Your entry must not offend anyone on the planet.

(That about covers it.)

## **6. Limit:**

Only one (1) entry per family, please.

Don't try to enter a bunch of times through phony accounts or you will be disqualified.

## **7. Selection and Notification of Winner:**

We will poll our Fam Club Members and have them choose their favorite videos. Pastor Robbie and Sadie will select a grand prize winner from the top three most popular choices. Grand prize winner will be announced on or around June 23, 2023.

If your name is selected we will attempt to call or email you. If we can't connect with you by June 22, 2023, we will pick a new winner. Sorry.

Once we connect, we will work with you to set up the exact days for you to visit. The visit must take place during the week of August 1st-5th, 2023.

**Official Rules**
